

# Rudy Hultgren Dedicated Service Award

This award is presented annually by the **Municipal Energy Agency of Nebraska (MEAN)** to an individual who displays commendable efforts in promoting public power and its ideals and in exemplifying what MEAN represents – devotion and dedication to public power and working together for the benefit of the community. **The Rudy Hultgren Dedicated Service Award winner receives a check in the amount of \$350.00 to be given to a special project.**

## Origin of the Award

Rudy Hultgren was a utility consultant and well-respected citizen of Lyons, Colo. who played an active leadership role in community service. The award was initiated in 1988.

## Eligibility

Any appointed or elected utility board member, city council official or employee of a MEAN member system is eligible.

## Award Criteria

- Exceptional leadership to municipal public power and within MEAN;
- Devotion to duty;
- Excellence in management and operation of a municipal electric utility system;
- Contribution to the betterment of the community and MEAN;
- Service and contributions toward the attainment of MEAN's goals and promotion of municipal cooperation.

- Implements programs beneficial to employees' professional/personal growth
- Active involvement in MEAN and NMPP Energy (board/committee service)
- Knowledge of municipal utility system
- Developer of services to benefit customers (trash collection, recycling, etc.)
- Key role in major upgrade to community's electric system
- Excellence in managing utilities and other municipal departments
- Active community member
- Forward-thinking leadership
- Well-respected by co-workers and community
